# Village of Napoleonville Minutes of Regular Council Meeting October 7, 2024

The Village of Napoleonville held a Regular Council Meeting on Monday, October 7, 2024, at the Administration Building Meeting Chamber. The session was called to order at 6:08 pm by Mayor Pro Tem Jupiter, the Clerk being present.

The Pledge of Allegiance was led by Alderwoman Jupiter, followed by a moment of silence, Alderwoman Jupiter led the invocation.

**Present:** Alderwoman Kia Converse, Alderwoman Velma Jupiter, and Alderwoman April Williams. Mayor Animashaun was absent. A quorum to conduct business was present.

Also present was Trina Animashaun.

#### **Approval of the Minutes**

Upon a motion by Alderwoman Converse seconded by Alderwoman Williams, the minutes from the Regular Council meeting on September 9, 2024, were approved. With a unanimous agreement from the Board, Mayor Pro Tem Jupiter declared the motion carried.

#### **Financial Reports**

Upon a motion by Alderwoman Converse, seconded by Alderwoman Williams the Board agreed to accept the financial reports from September 2024 were approved. With a unanimous agreement from the Board, Mayor Pro Tem Jupiter declared the motion carried.

### **Public Hearing Open**

Alderwoman Williams motioned, and Alderwoman Converse seconded, "THAT" a public hearing be open. Upon a unanimous agreement by the Board, Mayor Pro Tem Jupiter declared the motion carried.

Ordinance 24-06 was introduced to amend Chapter 13 Liquor and Alcoholic Beverages, adding Section 13:5 Regulations for Eating and Drinking Establishments., was presented for final adoption. With no comments from the public, Alderwoman Converse motioned and Alderwoman Williams second, "THAT" the Board adopt Ordinance 24-06. The vote is as follows:

Yeas: 2 Alderwoman Kia Converse and Alderwoman April Williams.

Nays: <u>0</u> Abstain: <u>0</u> Absent: 0

The Board unanimously agreed and Mayor Pro Tem Jupiterdeclared the motion carried.

Alderwoman Converse motioned and Alderwoman Williams second, "THAT" the public hearing be closed. The Board unanimously agreed and Mayor Pro Tem Jupiter declared the motion carried.

## **Public Comments Open**

Alderwoman Williams motioned, and Alderwoman Converse seconded, "THAT" the Board open a public comment session before discussing any agenda items. Upon a unanimous agreement by the Board, Mayor Pro Tem Jupiter declared the motion carried.

Ordinance 24-04 Amending Section 11:25 – 11:39 Manufactured Homes. After a brief discussion and no comments from the public, Alderwoman Converse motioned, and Alderwoman Williams second "THAT" a public hearing be set for November 9, 2024, to adopt Ordinance 24:04. With a unanimous agreement from the Board, Mayor Pro Tem Jupiter declared the motion carried.

Ordinance 24-07 was introduced, to amend Section 11:103 Halfway Houses Is Prohibited in the Village of Napoleonville. After a brief discussion and no comments from the public, Alderwoman Converse motioned, and Alderwoman Williams second "THAT" a public hearing be set for November 9, 2024, to adopt Ordinance 24:07. With a unanimous agreement from the Board, Mayor Pro Tem Jupiter declared the motion carried.

Ordinance 24-08 was introduced, to amend Section 8 Franchises, Electricity Franchise. After a brief discussion and no comments from the public, Alderwoman Converse motioned, and Alderwoman Williams second "THAT" a public hearing be set for November 9, 2024, to adopt Ordinance 24:08. With a unanimous agreement from the Board, Mayor Pro Tem Jupiter declared the motion carried.

Alderwoman Converse motioned and Alderwoman Williams second, "THAT" the public comments session be closed. Upon a unanimous agreement by the Board, Mayor Pro Tem Jupiter declared the motion carried
